Based on a review of the wetland delineation map, Wetland 1 is located in the northwestern corner of a vacant field and surrounded by uplands involving residential development immediately north and west. The delineation map shows the boundaries of the listed wetland is contained within the review area and a review of historical aerial photos provided in the delineation report and via Google Earth (photos taken 05/2018, 06/2017, 04/2017, 04/2015, 05/2011, 06/2010, 06/2008, 06/2006, 05/2005, 05/1992) primarily taken during the wetter months of the year, illustrate mostly dry conditions within the area. The Wisconsin Surface Water Data Viewer indicates the nearest (a)(1)-(a)(3) water is an unnamed tributary of Mud Creek located approximately 0.55 mile to the west of Wetland 1 and a review of floodplain maps indicate Wetland 1 is not within the mapped floodplain of this tributary. A review of a topographic map provided via Wisconsin Surface Water Data Viewer indicates a decrease in elevation from 840 to 810 towards the tributary to the west. The presence of uplands around the wetland, the change in elevation, the wetland not being within any mapped floodplain, and aerial photography, all indicate this wetland does not abut the tributary to the west, is not separated from this water by natural or man-made barriers, and does not receive flooding in a typical year from this water of the U.S. Therefore, Wetland 1 is a (b)(1) Non-adjacent wetland which is non-jurisdictional under Section 404 of the Clean Water Act.
