There are no “*navigable waters of the U.S.*” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Explain: **The review area contains two wetlands, labeled W-1 (0.36 acre) and W-2 (0.78 acre). These wetlands are isolated, per review of the July 2021 Heartland delineation report which included a delineation map, USGS topographic map, hydric soils map, Wisconsin Wetland Inventory map, 1-foot contours, and historic aerial photos. Both wetlands were created sometime between 1963 and 2000 as a result of gravel mining on the site. However, work has been abandoned since then. The wetlands are surrounded on all sides by the steep contours of the old pit, and there are no inlets/outlets associated with the wetlands. There are no surface or shallow subsurface connections to another aquatic resource. The nearest tributary is unnamed to the Fox River, approximately 700 feet to the east of W-2 with a large ridge in between.**

The wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential development and public roadway) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 and W-2 are not regulated by the Corps under Section 404 of the Clean Water Act.
