B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland delineation report submitted for this project documents that there are no aquatic resources within the 13-acre review area identified on the attached figures labeled as 2021-01645-EJI AJD Page 1 of 2 to 2 of 2. There are no NWI mapped wetlands or public waters, and soils data identified both predominately hydric and predominantly non-hydric soils in the project area. Per the offsite joint guidance between BWSR and St. Paul District, there are no wetlands present within the project area because although hydric soils are present, there are no NWI mapped wetlands and wet signatures were observed in only 20% of the historical images within the review area. The Decision Matrix was used to determined that field verification was not required and the area was not a wetland.
