Explain: **A wetland delineation identified two wetlands in the review area; Wetland 1 is approximately 0.19 acres (8,065 square Feet) and Wetland 2 is approximately 0.01 acres (328 square feet) and are located within depressions in the landscape adjacent to an existing quarry. Based on a review of the information provided and available off-site resources, these wetlands do not have surface or shallow subsurface connections to a water of the United States. These wetlands are not physically separated by man-made dikes or barriers, natural river berms, beach dunes, and the like from jurisdictional waters. These wetlands do not have ecological connections to a WOUS due to the lack of ecological resources and distance between the wetlands and the nearest tributary.**

The wetlands described above do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; are not known to be used for industrial purposes for interstate or foreign commerce. Therefore, these wetlands have been determined to be non-jurisdictional under the Clean Water Act because they lack connections and/or relationships sufficient to serve as a basis for jurisdiction.
