Explain: **The aquatic resources were delineated by Stantec Consulting Services Inc. on February 14, 2021. The review area is approximately 110.5 acres in size and contains one intrastate wetland. Wetland 1 (W1), which is 0.17 acre, is located in the Northeast corner of the review area. The surrounding land use is primarily agricultural and urban. Based on a review of the National Hydrography Dataset (NHD) the nearest waterway is an unnamed tributary (WBIC**

5036738) to Badger Mill Creek located approximately 0.60 miles North. Based on a review of aerial imagery (2020-2000), USGS Topography, The Wisconsin Wetland Inventory, the NRCS soils survey and the February 14, 2021 Stantec Wetland Delineation Report, W1 is an isolated concave depression in a farm field with no surface connection to WBIC 5036738. Based on this information W1 is isolated with no surface or shallow subsurface hydrologic connection or ecological connection to the nearest RPW or TNW. W1 does not border, neighbor, nor is contiguous with another water of the U.S. W1 is not separated from other WOUS by man-made dikes, barriers, or berms. W1 does not support a link to interstate or foreign commerce; it is not known to be used by interstate or foreign travelers for recreation or other purposes; it does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and it is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W1 is not regulated by the Corps under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
