- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review areas contain four wetlands in total, labeled W-9 (1,325 s.f.), W-10 (1,158 s.f.), W-13 (493 s.f.), and W-15 (196 s.f.). These wetlands are all isolated, based on a review of the March 2022 wetland delineation report by raSmith, which included a USGS topographic map, 1-foot contours, NRCS hydric soil data, Wisconsin Wetland Inventory, historic aerial photos, and ground level site photos. The wetlands are small, farmed depressions surrounded by upland agriculture. Based on the delineation report and aerial photography, there are no known inlets/outlets associated with any of the four wetlands. Aerial photos do not show confined surface or shallow subsurface connections to any downstream waters and the areas surrounding the wetlands are actively farmed. The nearest tributary to any of the four wetlands is unnamed to the Fox River, approximately 400 feet east of W-9.**

**The wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agricultural development) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands 9, 10, 13, and 15 are not regulated by the Corps under Section 404 of the Clean Water Act.**
