Request for water quality certification (WQC) under Section 401 of the Clean Water Act for 2022 Regional General Permits (RPGs) issued by the St. Paul District U.S. Army Corps of Engineers

Dear Mr. Kitchen:

The Lac du Flambeau Band of Lake Superior Chippewa Indians Natural Resources Program has reviewed the Corps letter dated September 20, 2022, requesting a water quality certification under 401 of the Clean Water Act. The Lac du Flambeau Band of Lake Superior Chippewa Indians (Tribe) deny without prejudice, certification of the following Corps 2022 Regional General Permits:

Enclosure A Bank Stabilization and Habitat Improvement

Enclosure B Beach Creation & Nourishment

Enclosure C Beach Raking

Enclosure D Minor Discharges

Enclosure E Piers and Docks

(401 water quality certification is not required for seasonally placed recreation structures.)

Enclosure F Transportation

Enclosure G Utilities

Enclosure H Wildlife Ponds

The Tribe is unable to provide 401 Certification for the proposed categories of activities under CFR 40 §121.7 (e) (2) (iii): Information required to ensure that Water Quality Standards will be met, must identify the project location and specific waterbody(s) within the exterior boundaries of the Reservation where the proposed activities will occur.

Additionally, under CFR 40 §121.7 (e) (2) (i) (ii): The Tribe is unable to certify the proposed categories of activities due to the lack of project specific information needed to determine if Tribal Water Quality Codes 28.105 (Designated Uses) and 28.106 (Criteria) would be met.
