- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Three waters onsite were determined to be isolated (Wetland 3, Wetland 4, Wetland 11). A review of aerial photography, topographic maps, and National Wetland Inventory maps was conducted. The data does not indicate a surface or shallow groundwater connection between these features to waters of the U.S. The NWI map documents all three resources. There were no outlets identified or any other surface connection to a water of the U.S. in any basin. There are no other indicators of a surficial hydrologic connection to any water of the U.S. Thus, Wetland 3, Wetland 4 and Wetland 11 are isolated wetlands and are non-jurisdictional.**


