Explain: There are 3 wetlands in the project area, labeled as Wetland 1, 2 and 3 on the attached figures labeled MVP-2017-00748-LMG Page 1 of 4 through Page 4 of 4. These are depressional basins that do not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries, as confirmed in the 17059 Nowthen Boulevard NW revised delineation report dated June 19, 2017. The wetlands are surrounded by upland, and have no swales, pipes or other means to connect them to waters of the U.S. (WOUS). We have determined that these wetlands are isolated depressions and not WOUS. A site visit was conducted on September 7, 2017 to confirmed no additional wetlands were on site. Numerous soil pits were dug in areas displaying wet signatures on aerial imagery. These areas did not meet any hydric soil indicators.

The waterbodies do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. These wetlands do not have an ecological connection to other waters within the review area. The waterbodies were determined to not be jurisdictional under the CWA.
