Explain: There are 3 wetlands in the project area; however, this JD is only for the wetland labeled as Wetland A on the attached figures labeled MVP-2017-02667-LMG Page 1 of 4 through Page 4 of 4. This is a depressional basins and that does not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries, as confirmed in the Lennar Lever St. NE Property Delineation Report dated August 4, 2017 and a site visit on August 10, 2017. The wetland is surrounded by upland, and has no swales, pipes or other means to connect it to waters of the U.S. (WOUS). We have determined that this wetland is an isolated depressions and not a water of the U.S.

The waterbody does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate or foreign commerce. This wetland does not have an ecological connection to other waters within the review area. The waterbody was determined to not be jurisdictional under the CWA.
