MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ [MVP-2023-01207-ACM](#), [MFR 1 of 1](#)

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

exclusions listed in 33 CFR 328.3(b).⁷ The review area contains a single feature, labeled Ephemeral Feature 1 on the attached MVP-2023-01207-ACM AJD Attachments, Page 2 of 2. As the 3DEP Digital Elevation Model (DEM) Map Service indicated a linear feature in a lower elevation, a site visit was conducted on November 3, 2023. The St. Paul District Description of Stream Features Worksheet was completed during the site visit and Ephemeral Feature 1 does not contain any of the characteristics of an Ordinary High Water Mark listed on that worksheet. The Regulatory Guidance Letter Number 05-05, Ordinary High Water Mark Identification was reviewed, and Ephemeral Feature 1 contains none of the characteristics of an Ordinary High Water Mark. There are no aquatic resources listed on the National Wetland Inventory, the National Hydrography Dataset, or topographic maps. The historic aerials accessed on the University of Minnesota Aerial Photographs Online database did not indicate a linear feature in this area. Ephemeral Feature 1 is a gully/erosional feature and meets the (b)(8) exclusion, therefore, the feature is not a Waters of the United States and is not jurisdictional under Section 404 of the Clean Water Act.
