Explain: **This AJD is limited to the boundaries of Wetland 1 within the review area. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states “For clarification, it should be noted that we generally do not consider the following waters to be “Waters of the United States....(c) Artificial lakes or ponds created by excavating and / or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing.” Wetland 1 was constructed in uplands and is a stormwater pond that was constructed as part of infrastructure that was installed for future developments in the area. Therefore, Wetland 1 is not considered to be a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act.**

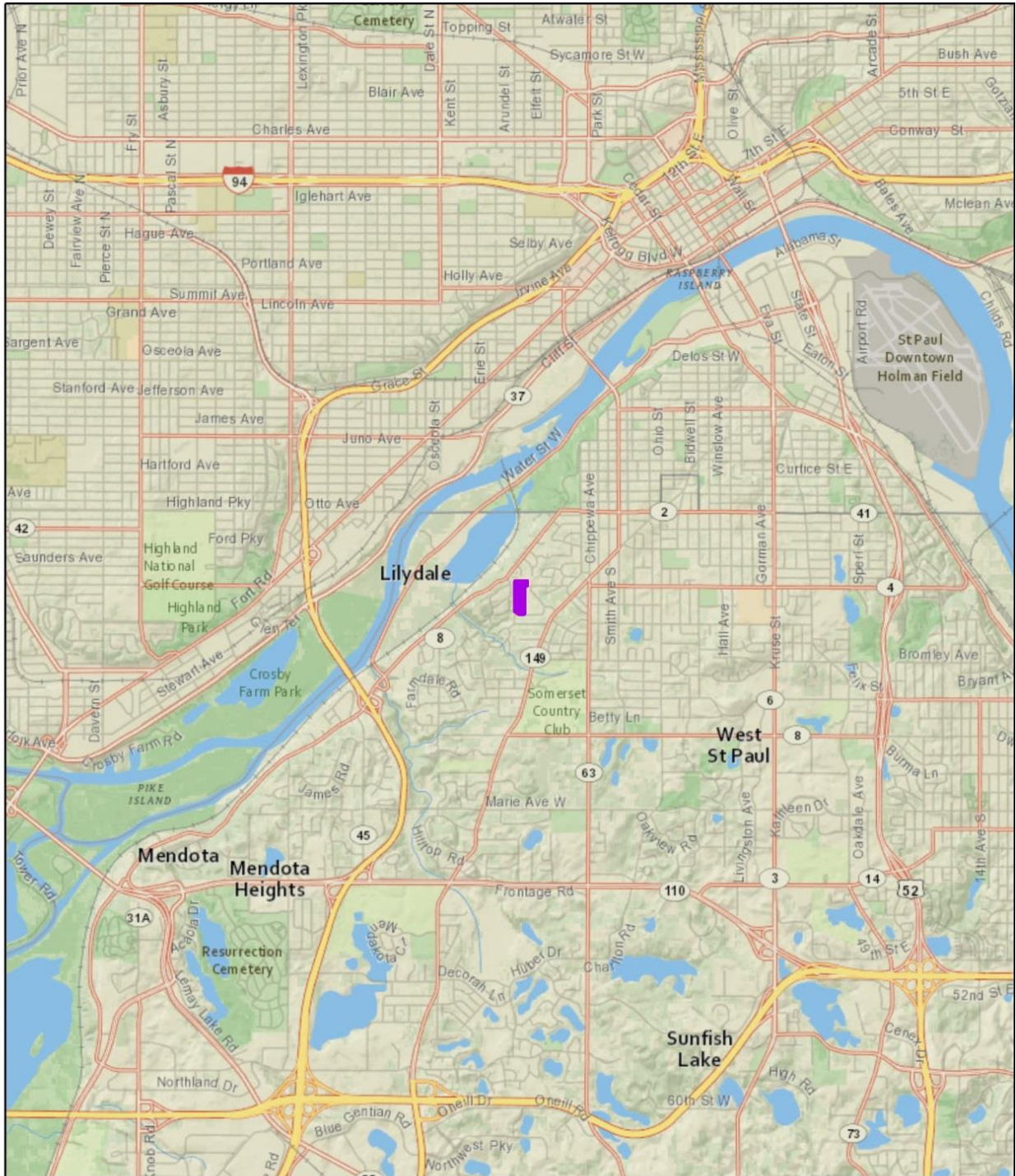

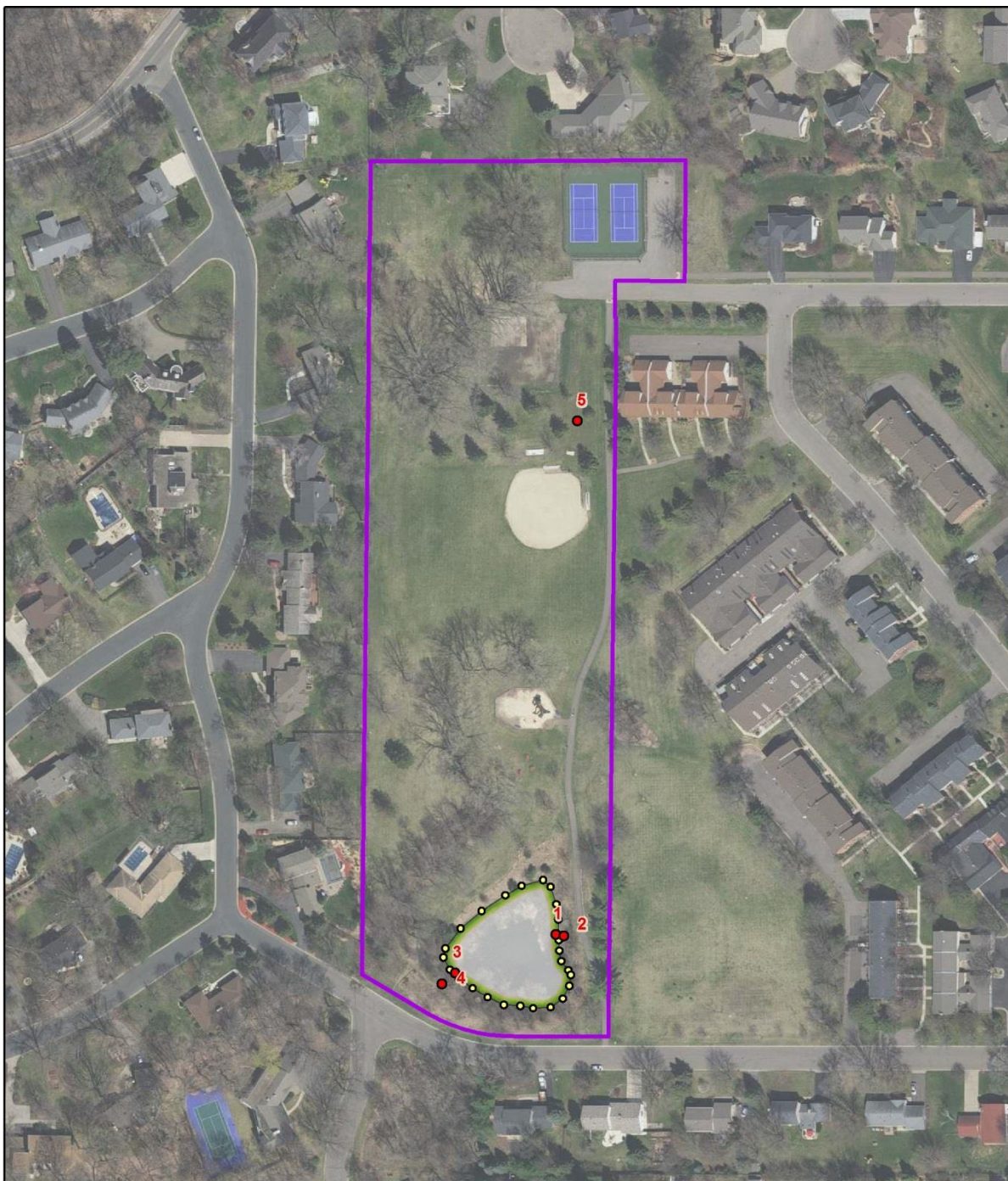
Ivy Hills Park Mendota Heights, MN
