The roadside ditches were constructed in uplands, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WOUS). This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation reports included with the January 2020 Revised Joint Application Form. Per the Rapanos decision, the evaluated ditches are not WOUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.
