Review of the Dakota County Soil Survey Geographic Database shows the wetland is located in a hydric soil unit completely surrounded by non-hydric soils. The National Wetland Inventory map does not depict the wetland and does not show the wetland being connected to or adjacent to any larger wetland complex that may be associated with a tributary. There were no outlets identified or any other surface or shallow subsurface connections to a water of the U.S. The wetland is surrounded by upland. There are no other indicators of a surficial hydrologic connection to any water of the U.S. Due to the disturbed nature of this area, the wetland does not have an ecological connection to other waters within or adjacent to the review area. Wetland WB01 is isolated and is non-jurisdictional.

The waterbody described above, Wetland WB01 does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; it does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and it is not known to be used for industrial purposes for interstate or foreign commerce. The waterbody has been determined to be non-jurisdictional under the Clean Water Act because the wetland lacks connections and/or relationships sufficient to serve as a basis for jurisdiction.
