Explain: **The agent on behalf of the applicant has provided an aerial analysis of Basin 2 and documented that it was upland prior to being graded in 2006. The grading was undertaken for a development. The road has not been constructed on top of the grading yet but the wetland has formed in the depression resulting from the grading.**

The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states "For clarification, it should be noted that we generally do not consider the following waters to be "Waters of the United States.... (e) Waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of Waters of the U.S." This basin is incidental to construction activities on the site. Therefore, Basin 2 is not considered a water of the U.S. and is not jurisdictional under Section 404 of the Clean Water Act.

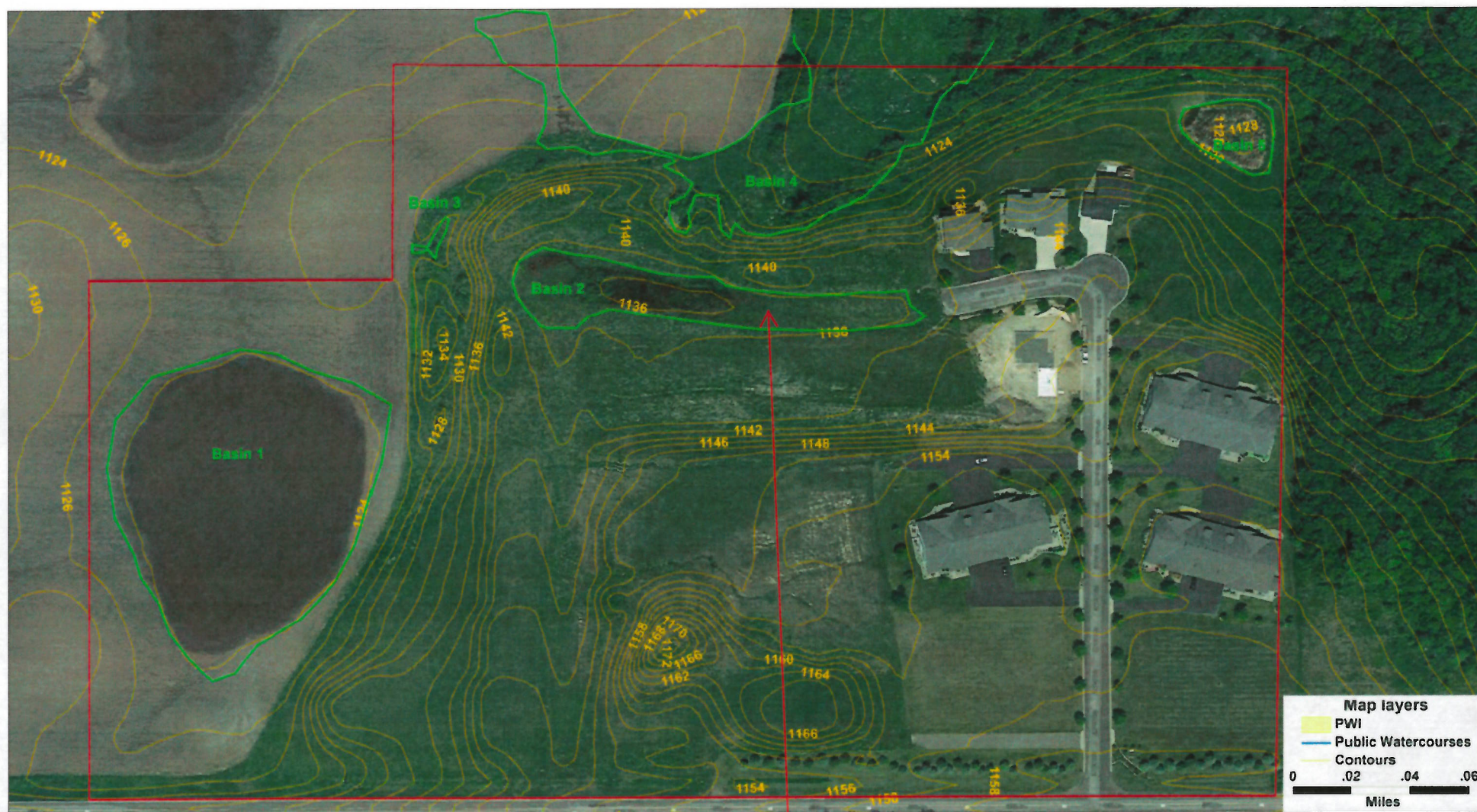
Figure 1 - Site Location Map
