Explain: **This JD is for the pond labeled as Wetland C (aka the Honeywell Pond) as shown on the attached figure. This wetland is not a jurisdictional waters of the U.S. (WOUS) because it was constructed in an upland area sometime between 1966-1979. This was confirmed by reviewing historic normal year aerial photographs, which do not show any historic hydrology indicators within or near the current location of the pond prior to 1979. The non-jurisdictional determinations for this basin was completed in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps generally does not consider certain waterbodies to be waters of the U.S., including: Artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing.**
