<u>D. ADDITIONAL COMMENTS TO SUPPORT JD:</u> The review area for this determination is limited to the boundaries of six roadside ditches labeled as Wet Ditch-1, Wet Ditch-2, Wet Ditch-4, Wet Ditch-6, Wet Ditch-15 and Wet Ditch-16, and four stormwater control features labeled as Wet Pond-5, Wet Pond-8, Wetland 11 and Wet Pond-12 on the attached figures and tables labeled MVP-2018-02059-BGO SP 1017-108 TH 212/CSAH 44 Interchange Project AJD Attachments, Pages 1-9 of 9. All of the labels for these aquatic resources are also highlighted in yellow on the attached figures. The total area of non-jurisdictional waters/features is approximately 6.76 acres.

The ditches are constructed features that are not relocated tributaries, are not excavated in a tributary, and do not convey perennial or intermittent flow. This was confirmed by reviewing aerial photography, national hydrography data, and the July 2018 wetland delineation report. Based on this review, the evaluated ditches are not jurisdictional under the 2015 Clean Water Rule because they meet the terms of paragraph (b)(3)(i).

The stormwater control features were constructed in dry land between 2003-2015 to convey, treat, or store stormwater from TH 212 and several residential developments located along CSAH 44. This was confirmed by

reviewing aerial photography, topographic maps, and soil survey data which shows the stormwater control features were constructed in dry land. Three separate wetland delineations were also completed in 2004, 2012, and 2013 for the Holasek Property (MVP-2008-05403-MMJ) and Putman Site at County Road 140 (MVP-2012-04679-MTS). Based on information found in the administrative record for 2008-05403-MMJ, the location of Wet Pond-12 was comprised entirely of dry land at the time of the delineation. The delineation for the Putman Site provides further documentation that Wetland-11 was predominantly constructed in dry land, except for a small portion of the stormwater control feature that was constructed within an existing man-made ditch located along CSAH 44. The ditch was located entirely in uplands and only exhibited ephemeral flow at the time of the delineation and, therefore, does not affect the jurisdictional status of Wetland-11. Based on this review, the evaluated stormwater ponds are not jurisdictional under the 2015 Clean Water Rule because they meet the terms of paragraph (b)(6).
