C. Additional comments to support AJD: The wetland is shown to continue offsite of the review to the northeast. The National Wetland Inventory identifies a stream northeast of the site approximately 0.17 miles away. It is not clear how far the wetland subject to this determination would continue to the northeast. A residential development exists between the wetland and the NWI listed stream. MNTOPO indicates elevation contours continue to lower towards the stream around the development. However, aerial imagery does not indicate the presence of a wetland between the northern extent of the development and the stream. In addition, a previous delineation on file indicates no wetland surrounds the stream where the elevation contours continue to. There is no evidence that the wetland continues towards the streams or abuts the stream. The wetland subject to this determination does not abut this stream nor any other stream or potential a(1)-(3) water.
