Explain: **The review area for this AJD includes one wetland (Wetland 1: 0.04 acre). Wetland 1 was examined, including a review of aerial photography, LiDAR maps, and National Wetland Inventory maps. The NWI map does not identify Wetland 1. The closest NWI wetland is several thousand feet to the east. There were no outlets identified or any other surface connection to a water of the U.S. in the wetland. There are no other indicators of a surficial hydrologic connection to any water of the U.S. Thus, the wetland is isolated and is non-jurisdictional.**




## Delineated Wetlands
