### SECTION II: SUMMARY OF FINDINGS

#### A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

#### B. CWA SECTION 404 DETERMINATION OF JURISDICTION.

There are no"waters of the U.S." within Clean Water Act (CWA) jurisdiction (as defined by 33 CFR part 328) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is 1 wetland and 2 storm ponds in the review area as shown on enclosed figures labeled MVP-2017-00076-LMG Page 1 of 4 through Page 4 of 4. Wetland 1 is a depressional basin and does not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries, as confirmed in the Sartell Schools Wetland Delineation Report dated January 5, 2017. The wetland is surrounded by upland, and has no swales, pipes or other means to connect it to waters of the U.S. (WOUS). We have determined that this wetland is an isolated depression and not a water of the U.S.

Wetland 1 does not support a link to interstate or foreign commerce because it is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate or foreign commerce. This wetland does not have an ecological connection to other waters within the review area. The waterbody was determined to not be jurisdictional under the CWA.

The 2 stormwater ponds were constructed in uplands in the early 2000s and are not a waters of the US. This was confirmed by reviewing the Stearns County soil survey which has the stormwater ponds and surrounding area mapped as non-hydric soil. The non-jurisdictional determination for these ponds is in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the US; artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins or rice growing.
