Explain: **There are 10 wetlands in the project area; however, this JD is only for wetlands labeled as WL 3, 4, 5, 9, and 10 on the attached figures labeled MVP-2015-00167-LMG Page 1 of 7 through Page 7 of 7. Wetlands 3, 4, 5, 9 and 10 are located on the LaBeaux Avenue property and are 0.20, 0.01, 0.56, 0.27, and 0.10 acre respectively. They are small depressional basins and they do not have a surface hydrologic connection to any navigable waters or their tributaries, as confirmed in the LaBeaux Avenue Wetland Delineation Report dated January 12, 2015. All five wetlands are surrounded by upland, and have no swales, pipes or other means to connect them to waters of the U.S. (WOUS). We have enough information to make the determination that Wetlands 3, 4, 5, 9, and 10 are isolated depressions and not waters of the U.S.**

The waterbodies do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. The waterbodies were determined to not be jurisdictional under the CWA.




Figure 2 - Property Boundary Map (2013 FSA Photograph)
