- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The review area contains six intrastate wetlands (Wetlands K, N, R, S, T, and U). These wetland basins are within farm fields. The wetlands are within an area mapped with Morely silt loam (MzdB), Elliott silty clay loam (EtA), Beecher silt loam (BcA), and Markham silt loam (MeB). MzdB and MeB are upland soil units. EtA and BcA are upland soil units with hydric inclusions (Ashkum). All six wetlands do not appear on the Wisconsin Wetland Inventory maps and are not within a 100-year floodplain. Wetlands K, N, R, S, T, and U are depressional basins and do not support a link to interstate or foreign commerce; they are not known to be used by interstate or foreign travelers for recreation or other purposes; they do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands K, N, R, S, T, and U are not regulated by the Corps under Section 404 of the Clean Water Act.**


