Explain: **The review area includes one aquatic feature identified as W3 and is 0.08 acre in size. W3 is a narrow stormwater conveyance feature which was constructed in uplands. The feature primarily functions as a stormwater conveyance feature, conveying stormwater runoff north into an enclosed storm sewer system. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and that do not carry a relatively permanent flow of water are generally not waters of the United States.**


