## **SECTION II: SUMMARY OF FINDINGS**

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains one wetland (Wetland A). The wetland delineation report submitted by Omnni Associates depicts this wetland as a degraded wet meadow. Wetland A, 0.101 acres in size, was identified as a wetland formed in a slight depression by repeated vehicle traffic in a field. This wetland is not within the 100-year floodplain and is not bordering, contiguous or neighboring another WOUS nor is this aquatic resource separated from another WOUS by man-made dikes, barriers, or berms. The closest tributary is approximately 500 feet to the east.

Wetland A does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The surrounding land use consists mostly of agricultual field and a recreational field (RV Camping for EAA show). The disturbance of surrounding land uses precludes an ecological connection to a WOUS. Furthermore, the area is hydologically isolated with no surface or shallow subsurface connections to a water of the United States. Therefore, the Corps has determined that Wetland A is not regulated by the Corps under Section 404 of the Clean Water Act.
