Explain: **The review area contains 2 wetlands (W-1 and W-4), shown on 2019-02880-AJK Figures 2-3 of 3. W-1 and W-4 are depressional features in a farmed wetland (0.13 and 0.07 acres, respectively). The wetlands were reviewed and determined not to have any hydrology connections. These wetlands were identified as isolated features and are not considered Waters of the U.S. An April 2019 wetland delineation report by Heartland Ecological Group, an NRCS hydric soils map, Wisconsin Wetland Inventory map, topographic map, Google Earth aerial photography, and ground level photos taken by WDNR in November 2019 were all reviewed. These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agricultural) and proximity to other waters, there is no ecological connection to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 and W-4 are not regulated by the Corps under Section 404 of the Clean Water Act.**
