There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains one aquatic resource (Wetland 2: 1,234 square feet) that is a ditch constructed in uplands prior to 1989 and two aquatic resources (Wetland 3: 2,972 square feet, and Wetland 4: 7,132 square feet) that are man-made depressions constructed in uplands as a result of grading and excavation work associated with residential development in adjacent upland areas. Review of site photos indicate all aquatic resources within the review area were created in uplands and do not convey a relatively permanent flow. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States and therefore not generally subject to Corps regulation; non-tidal drainage ditches excavated on dry land and water filled depressions that have developed as a result of construction activities. Further clarification regarding ditches can be found in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdication following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States.


