Explain: **The review area is approximately 29.40 acres in size and contains one intrastate wetland, Wetland 1 (W1), which is 0.69 acre in size. This aquatic resource was delineated by Heartland Ecological Group, Inc. in May 2018. W1 is isolated with no surface or shallow subsurface hydrologic connection or ecological connection to Rowan Creek to the north. W1 does not border, neighbor nor is contiguous with another water of the U.S. It is not separated from other WOUS by man-made dikes, barriers, or berms. The surrounding land use is mostly agricultural. Wetland 1 was previously disturbed for a borrow area in the 1960's.**

This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W1 is not regulated by the Corps under Section 404 of the Clean Water Act.
