Explain: The review area contains two aquatic resources (Wetland 1: 0.096 acre and Wetland 2: 0.015 acre) that are isolated depressions with no surface or shallow subsurface connection to Apple Creek, which is located approximately 900 feet to the northwest. These wetlands do not border, neighbor, nor are contiguous with another water of the U.S. and they are not separated from other WOUS by man-made dikes, barriers, or berms. The surrounding land use consists mostly of agricultural fields, precluding an ecological connection to a WOUS.

These aquatic resources do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce.
