Explain: **The review area contains one aquatic resource (Wetland 1: 0.030 acre) that is an isolated depression. This wetland was formed in uplands by surface water run-off and does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used in industrial purposes by industries in interstate commerce. Furthermore, this wetland is hydrologically isolated with no surface water connection to a water of the United States. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.**

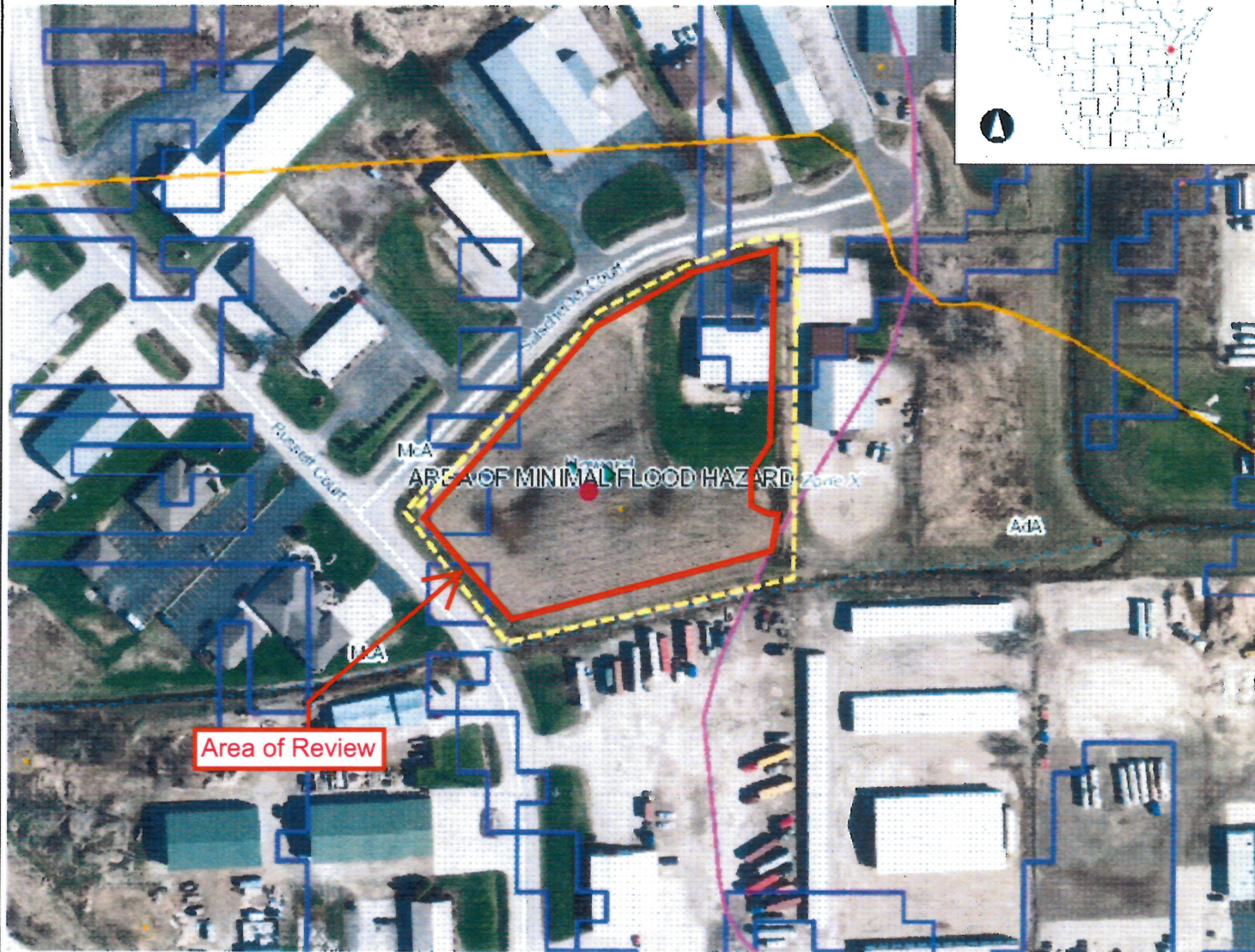
