Explain: **This determination is for Wetlands W1 and W2 within the review area as shown on the enclosed figure labeled MVP-2018-01961-EJW Page 4 of 4. These wetlands do not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries, as confirmed in the Wetland Delineation Report for Kettle Creek North dated July 4, 2018. These wetlands are surrounded by uplands and have no swales, pipes or other means to connect them to waters of the U.S. (WOUS). These wetlands do not enter any ditches that would provide a hydrologic connection to a downstream TNW.**

We have determined that these wetlands are isolated depressions and not WOUS. Wetland W1 and W2 do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. These wetlands do not have an ecological connection to other waters within the review area. The waterbodies were determined to not be jurisdictional under the CWA.
