### SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A field review of the site was conducted on May 4, 2018 to review the potentially jurisdictional waters Wetland 1 (0.17-acre), Wetland 2 (1.07-acre), and Wetland 5 (0.32-acre) as requested by Ayres Associates, acting on behalf of the property owner, Don Johnson. Corps staff determined that Wetlands 1, 2, and 5 are isolated wetlands with no hydrologic connection to a water of the United States. The delineation report provided to the Corps included a 150-acre property (Cumberland Business Park) owned by the City of Cumberland. The applicant has purchased an 8.16-acre parcel from the City of Cumberland for which the approved jurisdictional determination is being provided. The site generally slopes toward U.S. Highway 63. A thorough search to identify any culverts and/or other hydrologic connections on both sides of the highway was conducted, and none were found. These wetlands are located in small depressional areas. Based upon information gathered as a result of the field review and the wetland delineation report, Corps staff determined that the three wetlands are wholly surrounded by uplands and lack a jurisdictional connection to a water of the United States. The waterbodys described above, Wetlands 1, 2, and 5 do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; they do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and they are not known to be used for industrial purposes for interstate or foreign commerce. The waterbodies have been determined to be nonjurisdictional under the Clean Water Act because the wetlands lack connections and/or relationships sufficient to serve as a basis for jurisdiction.
