Explain: **The approximately 2.13-acre review area contains one isolated pond (Pond 1). Pond 1 is an isolated concave feature entirely surrounded by uplands. Based on a review of the National Hydrography Dataset (NHD) the nearest waterway is Antler Lake located approximately 0.20 miles west of Pond 1, which also has no surface water connection to any downstream waterway. The Wisconsin Wetland Inventory (WWI) shows the area as a small pond/wetland. The WDNR Surface Water Data Viewer shows the majority of the review area has mapped non-hydric soils present. Based on this information, the Corps has determined that Pond 1 is an isolated aquatic resource with no surface or shallow subsurface hydrologic connection or ecological connection to a RPW or TNW. Pond 1 does not border, neighbor, nor is contiguous with another water of the U.S. Pond 1 does not support a link to interstate or foreign commerce; it is not known to be used by interstate or foreign travelers for recreation or other purposes; It does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and it is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Pond 1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
