The review area contains eight aquatic resources; however, WB-B-06 is the only water included in this jurisdictional determination.

The Google Earth Pro historical photos and aerial photos taken in 2022, 2021, 2020, 2019, 2018, 2017, 2016, 2015, 2014, 2013, 2012, 2011, 2010, 2009, 2008, 2006, 2005, 2004, 2003, 1992, 1991, and 1985 show that Wetland WB-B-06 is entirely located in agricultural fields. Wetland WB-B-06 also does not drain to any relatively permanent waters as there are no adjacent waters as was shown on the National Wetland Inventory and USGS National Hydrography Database. USGS Soil Survey identifies the majority of soils for the wetland were hydric. Wetland WB-B-06 is not jurisdictional because the wetland is isolated and is not adjacent to a relatively permanent flow and does not drain to a water of the United States.

Wetland WB-B-06 does not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. Wetlands WB-B-06 is determined to not be WOUS and therefore, not jurisdictional under the CWA.
