The area within and adjacent to W-3 was subject to grading between 2000-2005, and is separated from W-1 by upland. W-4 is a wetland complex that is bordered by a railroad bed to the east. There appears to be a larger wetland complex to the south of W-4 outside of the review area, but based on the delineation report and aerial photographs these wetlands are separated by upland. W-5 is a small depression surrounded by upland. None of these features would be flooded by an (a)(1)-(a)(3) water in a typical year and there are no natural berms, banks, dunes, or similar natural features, or any artificial dikes, barriers, or similar artificial structures physically separating them from a paragraph (a)(1)-(3) water.
