Wetland B	0.05	acre(s)	(b)(1) Non-adjacent wetland.	The nearest a(3) water is Howard Lake, approximately 0.23 miles to the northwest of Wetland B. The wetland is a depressional feature located within a field. Contour maps in the wetland delineation report show that the wetland is mostly surrounded by upland with a gradual slope to the north. The wetland delineator did not note any surface water present during the site visit. Based on review of aerial imagery, there does not appear to be any surface water connection to an a(1)-a(3) water. Therefore, Wetland B is not considered a water of the U.S. under the Navigable Waters Protection Rule.	
Wetland C	0.02	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	Wetland C is a shallow linear swale within a roadside ditch adjacent to Highway 97. The wetland was constructed in uplands to provide drainage for Highway 97. Therefore, Wetland C is not considered a water of the U.S. under the Navigable Waters Protection Rule.	
Stormwater Treatment Pond	0.34	acre(s)	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	A stormwater treatment pond was constructed in upland between April 2018 and October 2019 based off of Google Earth Imagery. Therefore, the stormwater treatment pond is not considered a water of the U.S. under the Navigable Waters Protection Rule.
