Wet Ditch 6	0.008	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	Wet Ditch 6 was constructed in uplands to convey runoff from the adjacent roadway and is now a linear wetland that meets the definition of “ditch” under paragraph (c)(2). In addition, the ditch is not an (a)(1) water, is not a relocated tributary, was not constructed in a tributary, and was not constructed in an adjacent wetland. This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation figures. Based on this review, Wet Ditch 6 is not jurisdictional under the Navigable Waters Protection Rule because it meets the requirements of the exclusion for ditches under paragraph (b)(5).
Wetland 3, Wetland 5	0.0477	acre(s)	(b)(1) Non-adjacent wetland.	Wetlands 3 and 5 are wetland basins located on the north side of Brighton Beach Rd. Wetland 3 is surrounded by uplands and does not have a direct hydrologic surface connection to downstream waters. Wetland 5 is surrounded by uplands and has connection to Lake Superior via Wet Ditch 6. Subsequently, Wetland 5 does not have a direct hydrologic surface connection through a jurisdictional feature and is non-adjacent. Based on this review, Wetlands 3 and 5 are not jurisdictional because they meet the requirements of the exclusion for non-adjacent wetlands under paragraph (b)(1) and do not meet the definition of adjacent wetlands under paragraph (c)(1). This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation figures. Based on this review, Wetlands 3 and 5 are not jurisdictional under the Navigable Waters Protection Rule,
