Explain: **The review areas contains two aquatic resources (labeled as Wetland 3 and Wetland 10 on Figures) that are isolated depressions with no surface or shallow subsurface connection to any waters of the U.S. including the nearest aquatic resource which is an unnamed tributary located approximately 0.14 mile to the northeast of Wetland 3. These wetlands do not border, neighbor, nor are contiguous with another water of the U.S. They are not separated from other waters of the United States (WOUS) by man-made dikes, barriers, or berms. The surrounding land use consists primarily of agricultural fields, residential development, and a forested area immediately north of Wetland 3. Due to their size, Wetlands 3 and 10 provide limited habitat functions to WOUS and surrounding areas and provides no ecological connection.**

These aquatic resources do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these aquatic features are not regulated by the Corps under Section 404 of the Clean Water Act.
