Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains two wetlands, labeled W-6 (0.03 acre) and W-8 (0.03 acre). These wetlands are both isolated, per review of the January 2019 wetland delineation report which included topographic maps, NRCS web soil survey, WWI map, historic aerial photos, and ground level site photos. The wetlands are completely surrounded by upland based on the delineation report and have no inlets/outlets associated with them that would provide a surface water connection a downstream water. There are no surface or shallow subsurface connections to a WOTUS. The nearest tributary is Ryan Creek, approximately 1,700 feet to the southwest of W-6.

The wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential development and public roadway) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-6 and W-8 are not regulated by the Corps under Section 404 of the Clean Water Act.
