<u>D. ADDITIONAL COMMENTS TO SUPPORT JD:</u> The review area includes a 20-acre parcel identified in the attached drawings as the Approximate Project Boundary. As observed in aerial photos taken in 1938, 1949, and 1992, the review area appears to be used for agricultural use and does not include any wetland signatures. The parcel is mapped by the Web Soil Survey as non-hydric soil. On June 28, 2000, the Corps of Engineers authorized the Prairie Island Indian Community to dredge material from the bed of the Mississippi River (00-04164-MTV). The authorization identified the review area considered in this JD to be used as a dredged material disposal site. No wetlands or wetland impacts were identified at the time of this authorized work. Aerial photos taken in 2003 and 2016, as well as LiDAR imagery dated 2011 document on-going grading activity. The review area currently includes a 4.19 acre seasonaly flooded wetland (W1). The subject wetland appears to have formed after 2016 considering no wetland signatures are present prior to the 2016 photo and vehicle tracks are visible throughout the currently delineated wetland. Aerial photography from 2018 appears to show level or nearly level terrain throughout the review area which is confirmed by the Wetland Delineation Report which noted the topography of the site is between 680 and 690 feet mean sea level. LiDAR data from 2011 confirms topography within the area of the subject wetland ranged from 682 up to 698. Current topographic data confirms the area of the subject wetland to be at approximately 681.

¹ In many cases these excluded features will not be specifically identified on the approved JD form, unless specifically requested. Corps Districts may, in case-by-case instances, choose to identify some or all of these features within the review area.

The site has been used for construction activity since at least 2003 to the present for the stock piling, loading, and unloading of dredged and fill material for construction use. It is proposed that the site will continue to be used for this activity. Therefore, it is determined that the 4.19-acre seasonaly flooded wetland described in this JD is excluded as a water of the U.S. because it is a water-filled depression created in dry land incidental to construction activity.
