			Wetland C does not abut at least one point or side of a paragraph (a)(1)-(3) water. Based on the United States Geologic Survey and elevation contours it would not be flooded by an (a)(1)-(3) water in a typical year. There is not a natural berm, bank, dune, or similar natural feature physically separating it from a paragraph (a)(1)-(3) water. It is not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. Wetland C is associated with a swale in the southeast corner of the property. It is not within a floodplain and the only outlets are through overland sheet flow. Therefore, this wetland does not fall under Corps jurisdiction under the NWPR.
