Explain: **The review area contains one wetland, labeled W-1 (0.09 acre). W-1 is an isolated wetland surrounded by a mowed elementary school field. There are no inlets or outlets associated with W-1, based on the delineation report's narrative and aerial photos. The site is surrounded by residential development and a school, and there are no surface connections to any downstream waters. The closest mapped water is Lake Michigan, approximately 1.25 miles to the east.**

**The wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (residential development) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 is not regulated by the Corps under Section 404 of the Clean Water Act.**
