Explain: **This AJD is limited to the boundaries of Wetland 1. Based on review of aerial imagery and the wetland delineation report submitted by the requestor, we have determined that the wetland is isolated with boundaries that transition to uplands.**

Wetland 1 is located along the southern edge of the site boundary. Review of aerial imagery shows that a residential home was located where Wetland 1 is now located. The home was removed from the site in 2012. The wetland likely developed incidental to that work being completed. Review of the National Wetland Inventory (NWI) does not identify Wetland 1. Additionally, review of the National Hydrography Dataset (NHD) does not show a surface water connection to a water of the U.S. (WoUS).

Wetland 1 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. The wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland 1 is not regulated by the Corps under Section 404 of the Clean Water Act.
