There are no “navigable waters of the U.S.” within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Based on the wetland delineation report submitted by the requestor, aerial imagery, and LiDAR contours, we have determined that the wetland is isolated with boundaries that transition to uplands.**

Wetland A is a partially farmed, seasonally flooded wetland basin located along the western boundary of the site. The wetland delineation report provided 2-foot LiDAR contours of the site and shows that Wetland A is surrounded by upland. Google Earth imagery does not show a surface water connection to a water of the U.S. (WoUS). Aerial imagery indicates the wetland formed as a result of runoff it receives from the adjacent residential development. The soils are characterized as Angus-Le Sueur complex, 1 to 6 percent slopes, a non-hydric soil. The wetland is not mapped on the National Wetland Inventory (NWI) and the National Hydrography Dataset (NHD) does not show a surface water connection to a WoUS. No natural or constructed outlets were noted by the wetland consultants for the project.

Wetland A does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. This wetland does not have an ecological connection to a WoUS. Furthermore, the area is hydrologically isolated with no surface water connections to a WoUS. Therefore, the Corps has determined that Wetland A is not regulated by the Corps under Section 404 of the Clean Water Act.
