The Contour Map submitted in the wetland delineation report indicates that Wetlands 3, 4, 5, and 6 are depressional basins, completely surrounded by uplands. This was confirmed using Google Earth imagery from 1991, 2003- 2006, and 2008-2020. This aerial imagery also showed no tributaries within the vicinity of Wetlands 3, 4, 5, and 6. The closest tributary is Rush Creek which is over a mile away from the subject wetlands. Wetlands 3, 4, 5, and 6 do not share a surface water connection with an a(1)- a(3) water. Therefore, Wetlands 3, 4, 5, and 6 are not considered waters of the U.S. under the Navigable Waters Protection Rule.
