Explain: **The review area for this jurisdictional determination includes 3 roadside ditches labeled as Wetland 1, 1b and 28. The total area of non-jurisdictional waters/features is approximately 0.08-acre.**

The roadside ditches were constructed in uplands, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WoUS). This was confirmed by reviewing aerial photography, national hydrography data, the wetland delineation report, and a previous site visit in 2019. Per the Rapanos decision, the assessed ditches are not WoUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.
