NRCS Soil Maps classify the soil as predominantly Shorewood silty clay loam. The wetland does not abut this a(2) water and is not inundated by flooding in a typical year from it. Wetland 2 is not separated from an a(1)-a(3) water by only a natural feature or an artificial feature. Wetland 2 is therefore not a water of the U.S. due to its lack of hydrologic connection to an a(1)-a(3) water.
