SECTION II: SUMMARY OF FINDINGS

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 3 3 CFR part 329) in the review area.

2. Non-regulated waters/wetlands (check if applicable):¹

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area includes three wetlands, labeled Wetlands A (0.16 acre), B (0.06 acre), and C (0.06 acre). These wetlands are isolated, based on a review of the April 2022 wetland delineation report by Wetland and Waterway Consulting and other desktop resources, which included USGS topography, NRCS hydric soils data, Wisconsin Wetland Inventory, historic aerial photos, and ground level site photos. The wetlands are situated in shallow farmed depressions surrounded by upland, based on the delineation report's data points and recent aerial photos. The review area is bordered by residential development on all sides. There are no surface or shallow subsurface connections between these wetlands and any downstream waters, based on a review of recent aerial photos and topography showing an absence of any flow. Based on the delineation report, there are no inlets/outlets associated with any of the wetlands. The nearest tributary to any of these wetlands is Pike Creek, approximately 0.56 mile to the east.

The wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (active farmland and residential development) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that Wetlands A, B, and C are not regulated by the Corps under Section 404 of the Clean Water Act.
