The contour map submitted in the joint application and Google Earth aerial imagery indicate that Kuester Slough is completely surrounded by upland. There are no tributaries exiting from Kuester Slough. There is no apparent surface water flow from Kuester Slough to an (a)(1) water. The closest (a)(1)-(a)(3) water is the Minnesota River which is approximately 2 miles south of Kuester Slough. Kuester Slough is not inundated by flooding of the Minnesota River. Therefore, Kuester Slough is not considered waters of the U.S. under the Navigable Waters Protection Rule.
