  - Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area contains a 0.19-acre waterfilled depression (W-1) created in upland and is not a water of the U.S. Google Earth aerial photos, the Surface Water Data Viewer (SWDV), and the 2012 OTIE and 2018 Heartland Ecological Group Inc. wetland delineation reports were reviewed. The waterfilled depression is not mapped as wetland in the SWDV and the depression was not delineated as wetland in the 2012 OTIE wetland delineation report. Aerial photos show a gravel road, to support a new substation, was constructed just south of the depression between 2011 and 2014. The construction and grading activity associated with the new roadway appears to have created the waterfilled depression within the review area of W-1. The determination of no jurisdiction for the waterfilled depression is in accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), which states that the Corps does not generally consider the following to be waters of the U.S.; waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel (see 33 CFR 328.3(a)).
