Based on a review of historic and current aerial photography, USGS Topographic Maps, Lidar Imagery, Wisconsin Wetland Inventory, and June 2021 Ecosystems, LLC Wetland Delineation Report, we have determined Wetland 2 is not adjacent to Wetland 1, nor to the unnamed tributary to Little Rib River. Wetland 2 is concave and surrounded by upland features. A surface hydrologic connection from Wetland 2 to an (a)(1)-(3) water does not exist. Wetland 2 does not meet the NWPR adjacency definition. |
